## FYOUTURE PRIVACY POLICY

This Policy was created to safeguard both the public- and non-public information of all individuals and entities using the Fyouture mobile app. Our default privacy settings limit the information displayed in your profile to and other reasonable community limitations that follow industry best practice. Fyouture's Privacy Policy is designed to help you understand how we collect and use the personal information you decide to share, and help you make informed decisions when using. By using or accessing the Fyouture mobile app, you are accepting the practices described in this Privacy Policy. This privacy statement covers the site [www.fyoutureapp.com](http://www.fyoutureapp.com) and its directly associated domains.

When you access Fyouture you provide us with two types of information: personal information you knowingly choose to disclose that is collected by us and other information collected by us as you interact with our website or mobile application. When you register with Fyouture, you provide us with certain personal information, such as your name, your email address, your telephone number, your address, your gender and any other personal or preference information that you provide to us. When you enter Fyouture, we collect your browser type and IP address. This information is gathered for all Fyouture visitors. In addition, we store certain information from your browser using "cookies." A cookie is a piece of data stored on the user's computer tied to information about the user. We use session ID cookies to confirm that users are logged in. These cookies terminate once the user closes the browser. By default, we use a persistent cookie that stores your login ID (but not your password) to make it easier for you to login when you come back to Fyouture. You can remove or block this cookie using the settings in your browser if you want to disable this convenience feature.

When you use Fyouture, you may set up your personal profile and start sending messages or media to specified individuals in the distant future. We collect this information so that we can provide you the service and potentially offer personalized features. In most cases, we retain it so that, for instance, you can return to view prior messages you have sent. When you update information, we usually keep a backup copy of the prior version for a reasonable period to enable reversion to the prior version of that information. All information contained within uploaded media through the mobile app will be at your own risk. Please be aware that no security measures are perfect or impenetrable and that we cannot control the actions of other users with whom you may choose to share your information. Therefore, we cannot and do not guarantee that User Content you upload to the

mobile app will not be viewed by unauthorized persons. We are not responsible for circumvention of any privacy settings or security measures.

You understand and acknowledge that, even after removal, copies of User information may remain viewable. Any improper collection or misuse of information provided on Fyouture is a violation of the Fyouture Terms and Conditions. By using Fyouture, you are consenting to have your personal data transferred to and processed in the United States.

Fyouture does not knowingly collect or solicit personal information from anyone under the age of 13 or knowingly allow such persons to register. If you are under 13, please do not attempt to register for Fyouture or send any information about yourself to us, including your name, address, telephone number, or email address. No one under age 13 may provide any personal information to or on Fyouture. If we learn that we have collected personal information from a child under age 13 without verification of parental consent, we will delete that information as quickly as possible. If you believe that we might have any information from or about a child under 13, please contact us immediately. We recommend that minors over the age of 13 ask their parents for permission before sending any information about themselves to anyone over the Internet.

When you register with Fyouture, you create your own profile and privacy settings. We may occasionally use your name and email address to send you notifications regarding new services offered by Fyouture that we think you may find valuable. Profile information is used by Fyouture primarily to be presented back to and edited by you when you access the service and to be presented to others permitted to view that information by your privacy settings.

Fyouture may send you service-related announcements from time to time through the general operation of the service. Generally, you may opt out of such emails, though Fyouture reserves the right to send you notices about your account even if you opt out of all voluntary email notifications. Fyouture may use information in your profile without identifying you as an individual to third parties. We do this for purposes such as aggregating how many people in a network can be categorized.

Our network architecture and your privacy settings allow you to make informed choices about who has access to your information. We do not provide contact information to third party marketers without your permission. We share your information with third parties only in limited circumstances where we believe such sharing is 1) reasonably necessary to offer the service, 2) legally required or, 3)

permitted by you. Unlike most sites on the Web, Fyouture limits access to site information by third party search engine "crawlers" (e.g., Google, Yahoo, MSN, Ask). Fyouture takes action to block access by these engines to personal information beyond your name, profile picture, and limited aggregated data about your profile. We may provide information to service providers to help us bring you the services we offer. Where we utilize third parties for the processing of any personal information, we implement reasonable contractual and technical protections limiting the use of that information to the Fyouture-specified purposes.

You may opt-out of any sharing of certain or all information through the Settings page. In addition, third party developers who have created and operate the Mobile Application, may also have access to your personal information (excluding your contact information) if you permit the Application to access your data. Before allowing any Platform Developer to make any Platform Application available to you, Fyouture requires the Platform Developer to enter into an 'Acceptable Use' agreement which, among other things, requires them to respect your privacy settings and strictly limits their collection, use, and storage of your information. However, while we have undertaken contractual and technical steps to restrict possible misuse of such information by such Platform Developers, we cannot and do not guarantee that all Platform Developers will abide by such agreements. Please note that Fyouture does not screen or approve Platform Developers and cannot control how such Platform Developers use any personal information that they may obtain in connection with Platform Applications.

We may be required to disclose user information pursuant to lawful requests, such as subpoenas or court orders, or in compliance with applicable laws. We do not reveal information until we have a good faith belief that an information request by law enforcement or private litigants meets applicable legal standards. Additionally, we may share account or other information when we believe it is necessary to comply with law, to protect our interests or property, to prevent fraud or other illegal activity perpetrated through the Fyouture service or using the Fyouture name, or to prevent imminent bodily harm. This may include sharing information with other companies, lawyers, agents, or government agencies.

If the ownership of all or substantially all the Fyouture business were to change, your user information may be transferred to the new owner so the service can continue operations. In any such transfer of information, your user information would remain subject to the promises made in this Privacy Policy. When you use Fyouture, certain information you share with third parties such as personal information, comments, messages, photos, videos, may be shared with other users in accordance with the privacy settings you select. All such sharing of

information is done at your own risk. Please keep in mind that if you disclose personal information in your messages this information may become publicly available.

Fyouture may contain links to other websites. We are not responsible for the privacy practices of other web sites. We encourage our users to be aware when they leave our site to read the privacy statements of each web site that collects personally identifiable information. This Privacy Policy applies solely to information collected by the Fyouture Mobile Application. Third party advertisers may download cookies to your computer to measure the effectiveness of their ads and to personalize advertising content. In this way, they may compile information about where individuals using your computer or browser saw their advertisements and determine which advertisements are clicked. Fyouture does not have access to or control of the cookies that may be placed by any third party advertisers. Third party advertisers have no access to your contact information stored on Fyouture unless you choose to share it with them. This privacy policy covers the use of cookies by Fyouture and does not cover the use of cookies or other tracking technologies by any advertisers.

Access and control over most personal information on Fyouture is readily available through the user profile. Fyouture users may modify or delete any of their profile information at any time by logging into their account. Information will be updated immediately. Individuals who wish to deactivate their Fyouture account may do so on the applicable page. Removed information may persist in backup copies for a reasonable period but will not be generally available to members of Fyouture. Fyouture will take appropriate precautions to protect users' information. Your account information is located behind a firewall. Because email and instant messaging are not recognized as secure communications, we request that you not send private information to us by email or instant messaging services. If you have any questions about the security of Fyouture, please contact us.

### **Data Deletion Requests**

Users may request the deletion of their personal data at any time. To do so, users can send a short email to [support@fyoutureapp.com](mailto:support@fyoutureapp.com) from the email address associated with their Fyouture account, including their Fyouture username in the message. We will use the provided username and the sender's email address to verify the user's identity before processing the deletion request. Once verified, we will process and complete the data deletion request

within 21 days, in accordance with applicable laws and our data retention practices.

Your use of Fyouture, and any disputes arising from it, is subject to this Privacy Policy as well as our Terms and Conditions and all its dispute resolution provisions including arbitration, limitation on damages and choice of law. We reserve the right to change our Privacy Policy and our Terms and Conditions at any time. Non-material changes and clarifications will take effect immediately, and material changes will take effect within 2 days of their posting to the website. If we make changes, we will post them and will indicate at the top of this page the policy's new effective date. If we make material changes to this policy, we will notify you here, by email, or through different means. We encourage you review this policy on an ongoing basis so that you understand our current privacy policy. Unless stated otherwise, our current privacy policy applies to all information that we have about you and your account.
